

Shammy Shine Unlimited Wash Subscription Agreement

Terms and Conditions

For the Vehicle registered with _____, license plate number _____, an Unlimited Wash Tag installed in that vehicle provides unlimited washes at the Wash Level selected commencing today, _____, 20__ ("Subscription Date"), until this date next month, and thereafter for each subsequent month.

Wash Level

Unlimited Express _____ Express Exterior Wash only at Participating locations

Unlimited Supreme _____ Gold Supreme Express only at Participating locations

Tag Installation and Removal

My Unlimited Wash Tag will be installed by Shammy Shine staff. The tag will be placed inside the vehicle's front windshield. Upon cancellation of the membership evidenced by this Subscription Agreement, I agree to remove the Shammy Shine Unlimited Wash Tag from my car.

Tag Replacement

I acknowledge that removal of the tag or damage to it is likely to make it non-functional. If this tag is removed or damaged, Shammy Shine will provide and install a replacement at a cost of five dollars (\$5.00) provided the subscription is paid through the following month.

Payment

Until the Unlimited Wash membership evidenced by this Subscription Agreement is cancelled in writing, I agree that for each subsequent month Shammy Shine Car Washes may charge my credit card on the Subscription Date each month (or on the last day of any month in which the original Subscription Date is a date later than the last day of the month to be charged) the indicated amount, as it may be adjusted from time to time, for the Wash Level selected.

In the event that my credit card expires or its use is otherwise limited by the issuer and Shammy Shine is unable to charge the credit card in accordance with these payment terms, I will promptly either renew the credit card or provide Shammy Shine with an alternate credit card; and if I do not, I agree Shammy Shine may deactivate my Unlimited Wash Tag. I also agree that I waive any and all right to withhold or delay payment of the related credit card charges, whether as described in my agreement with the credit card issuer or otherwise.

Shammy Shine Car Washes will not be held responsible in cases where the car wash is closed for whatever reason. Reasons may include but are not limited to weather, holiday, or equipment malfunction/renovation.

Unlimited Wash subscription cannot be combined with any other offers, discounts, or club plans.

Eligibility

Only personal vehicles are eligible for this program. Business vehicles may be eligible to participate in our Commercial Fleet Wash Program—Please ask about our Commercial Fleet Program.
